

PROTECTION OF PERSONAL DATA

(Enter the Credit Intermediary's name), hereinafter also referred to as Linked Credit Intermediary of the CENTURY 21 Portugal Network, respects your privacy, and values the relationship it maintains with its customers.

This information is intended to inform how the Linked Credit Intermediary of the CENTURY 21 Portugal Network processes its customers' personal data, and ensures their privacy in the development and performance of its activities.

The Linked Credit Intermediary of the CENTURY 21 Portugal Network acts as Responsible for Processing your personal data, under the terms of the General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27, 2016), insofar as it collects and reviews its customers' personal data for developing and executing the financial mediation activity it proposes.

The Linked Credit Intermediary of the CENTURY 21 Portugal Network will only process your personal data for the strict purpose for which you request its intermediation **(Credit and/or Insurance cases)**, never using your personal data and documentation for any other purposes.

In this context, and in order for the Linked Credit Intermediary of the CENTURY 21 Portugal Network to be able to offer you the best proposals and the most appropriate solution to your needs, it will have to convey your personal data to one or more Banking Institutions such as **(enter the name of the Banks with which it has a binding contract signed, and which are registered with the Bank of Portugal, with the respective LINK TO EACH BANK)**, based in Portugal, of which it is a Linked Credit Intermediary (hereinafter Partner Banking Institutions), namely your personal identification data, biographical data, contact details, financial, education and employment data.

Conveying your personal data to such partner Banking Institutions has the following purposes:

- a) Presentation or proposal of consumer credit agreements;
- b) Credit intermediation with its partner Banking Institutions:
- c) Assistance to consumers, by carrying out preparatory acts or other pre-contractual management procedures connected to credit agreements that have not yet been presented or proposed;
- d) Conclusion of credit agreements with consumers on behalf of creditors (if applicable).

You can consult the list of partner Banking Institutions that are Linked Credit Intermediaries of the CENTURY 21 Portugal Network as credit intermediaries at <https://www.bportugal.pt/intermediarios-credito/>.

The Linked Credit Intermediary of the CENTURY 21 Portugal Network will inform you in advance of the partner Banking Institutions with which your personal data will be actually shared, so that you can oppose such sharing of your personal data with any of them.

After any such personal data is conveyed by the Linked Credit Intermediary of the CENTURY 21 Portugal Network to the partner Banking Institutions, they shall act as Data Officers, and your personal data will be subject to automated and non-automated processing, for the aforementioned purposes of analysis and presentation of a credit proposal and conclusion of the respective agreement.

For further information on how each of the partner Banking Institutions processes your personal data, you can consult their Privacy Policies or request more information directly from them.

Your personal data will be kept by the Linked Credit Intermediary of the CENTURY 21 Portugal Network and by the partner Banking Institutions to which your data is conveyed, for the period of time required to fulfil the aforementioned processing purposes, and for the periods of time required for compliance of legal obligations, after which they will be deleted or anonymized.

As Data Subject, you can exercise your rights of access, rectification, deletion, limitation/restriction, portability or right to oppose the processing of your personal data, through a written request to _____, or through the email address _____ **(the Credit Intermediary must enter the channels available for this purpose).**

Under the terms of the General Data Protection Regulation, Data Subjects may also exercise their rights of access, rectification and deletion, before the partner Banking Institutions with which the Linked Credit Intermediary of the CENTURY 21 Portugal Network has shared their personal data. If you wish to do so, you must address your request to the Data Protection Officer (DPO) of the target Banking Institution or use any other channel provided by the latter for this purpose.

Data Subjects also have the right to file complaints with the National Data Protection Committee.

the financing proposals, to acknowledge the decisions that may be taken on the

financing(s), and also to receive data on the date and amount of the contract entered into.

The Declaring Party (ies) has (have) the right to withdraw these consents through the means indicated in the above information on Protection of Personal Data for the purpose of exercising their rights, without compromising the lawfulness of the processing already carried out until then. The information on Protection of Personal Data and the Declaration constitute a single document. By signing the Declaration, the Declaring Party (ies) is (are) confirming that they are aware and agree with the information provided in this document, as well as declare, for all due purposes and intents, that they are hereby contracting with **(enter the name of the Credit Intermediary)** the provision of a credit intermediation service, while thus renouncing all and any other credit intermediaries.
